

PARENTAL CONSENT FORM: PARTICIPATION, SUPERVISION & TREATMENT OF A MINOR CHILD

* *NOTE: This form is required for participation by any MINOR CHILD under the age of 18.

Policy for Minor Child's participation in volunteer activities at the construction site:

Construction sites and the activities that take place there are inherently dangerous for children. Habitat understands that the job site can provide a great learning experience for children but requires that when children are present, they are adequately supervised and working directly with their parent or guardian or another adult volunteer whom their parent has appointed to be their chaperone. Chaperones will be assigned the same tasks as the children whom they are supervising and will be required to work with them at all times. Youth volunteer age guidelines are as follows:

- Volunteers 18 years old or older may participate in all construction activities.
- Ultra-hazardous activities such as using power tools, excavation, demolition or working on rooftops is not permitted by anyone under the age of 18.
- 16 and 17 year olds can perform limited, safe construction activities under the direct supervision of their parent or legal guardian or another adult volunteer whom their parent or guardian has appointed in writing to be their chaperone.
- 14 and 15 year olds can help with non-construction activities, such as cleaning, organizing and landscaping, as long as they are removed from any areas where power tools and heavy machinery are in use or where work is being performed above them. 14 and 15 year olds must work under the direct supervision of their parent or legal guardian or another adult volunteer whom their parent or guardian has appointed in writing to be their chaperone.
- Children under the age of 14 are not permitted on the job site. The above guidelines are subject to Habitat's discretion, as exercised by the construction manager or other Habitat representative in control of the construction site. Habitat may refuse to permit any person under the age of 18 to conduct any work on a construction site, at any time, in Habitat's sole and absolute discretion.
